The Commission has approved the schedule for undertaking Special Summary Revision of Electoral Rolls with reference to 01.01.2014 as the qualifying date in all 294 Assembly Constituencies of the State. According to which, draft rolls shall be published on 15.11.2013 followed by final publication on 16.01.2014. As the State Government has declared holiday on 15.11.2013 on account of Moharrum instead of 14.11.2013, the Election Commission of India has approved the following revised schedule for Summary Revision of Electoral

Rolls with reference to 1.1.2014 as the qualifying date.

All eligible citizens who will attain 18 years of age as on 01.01.2014 and those missed to enroll themselves in earlier occasions, can file their applications for enrolment, objections and correction till 10th December, 2013 through e-Registration at ceoandhra.nic.in or to the ERO / AERO / BLO in person or by post.

It may be noted that the names of the accepted persons will form part of Supplement-1 and these names will appear in Final roll to be published under SRER, 2014 on 16.01.2014 and EPICs (Voter ID Cards) will be issued on 25.01.2014-National Voters' Day.
